The current shareholding of the Company and VHL is 37.74% and 10.26% respectively and the completion of the above transaction is subject to: (i) the Company and/ or VHL acquiring balance equity shares in JTCL held by Macquarie SBI Infrastructure Investments Pte Limited, SBI Macquarie Infrastructure Trust and other shareholders of JTCL; and (ii) completion of certain conditions precedent including approval of the lenders of JTCL and the Madhya Pradesh Road Development Corporation Limited.
